Summary of Professional Experience/Bio

Dr. Kelly Graves is an international presenter in the areas of trauma, trauma-informed care, Adverse Childhood Experiences (ACEs), and resiliency. She is sought after as a trainer and technical assistance provider in the areas of trauma and resilience, recently assisting in Canada, Guam, Japan, and several other countries and states. She is a consultant with the Office for Victims of Crime, OVC Training and Technical Assistance Center (OVC TTAC) with the United States Department of Justice, and the University of North Carolina - Chapel Hill AHEC Training Partnership program. She was invited to the White House under the Obama Administration to participate in Think Tank sessions on building community safety and resiliency. Dr. Graves is a clinical psychologist in NC and spent almost 16 years in academia in the UNC system. As a retired tenured Associate Professor, Dr. Graves felt the call to move from the classroom to the community. So, she founded Kellin, PLLC, and its non-profit partner the Kellin Foundation, which has now been recognized nationally and a partner with the National Child Traumatic Stress Network (NCTSN). She is accomplished scholar with dozens of peer-reviewed publications, books, and book chapters, and sits on several statewide boards. Dr. Graves believes strongly in bridging research to practice in community-based settings, and has implemented dozens of large grants resulting in systems change and enhanced service delivery. She co-developed the Greensboro Child Response Initiative, a law enforcement-mental health partnership model, which was supported by US Department of Justice and has now been replicated nationally in at least four different jurisdictions. Dr. Graves has extensive experience providing direct clinical services as well, which provides a unique perspective in her trainings and workshops. She is one of only a handful of clinicians in North Carolina to be nationally certified in trauma-focused cognitive behavioral therapy (TF-CBT), with experience both as a clinical and as a trainer. She is also certified in EMDR, Seeking Safety, and several other trauma-specific treatment modalities. Her awards include the American Psychological Association Division 56 Trauma award, the Triad Business Journal Top 40 Leaders Under 40 award, UNCG's Distinguished Alumni Award, North Carolina Psychological Association Sally R. Cameron Award, named as a Top Psychologist award with the International Association of Health Care Professionals, a Military Coin of Distinction for her work with military and veteran populations, and several others. True to her personal values, she loves to prioritize time with her husband and two daughters where they can frequently be found cheering on their favorite sports teams, engaging in board game battles, traveling, and volunteering in the community.

I served as a tenured faculty member to the Department of Human Development and Services within the School of Education at NC A&T State University. I worked across the clinical mental health counseling and rehabilitation and counselor education academic programs at both the masters and doctoral level. I have served as an instructor as well as an advisor and am actively involved in the strategic planning for the department. I have been instrumental in the development of the new Ph.D. program within the department, particularly with its emphasis on trauma and trauma-informed care in behavioral health settings. This Ph.D. program is the first of its kind at an HBCU, and I have developed a trauma-specific track of coursework that students can pursue if interested in specializing in this area.

As the founding Executive Director of the Center for Behavioral Health and Wellness from 2011-2015, I was responsible for leading an interdisciplinary group (public health, social work, psychologists, psychiatrists, health educators, licensed professional counselors, criminologists, peer support specialists, substance abuse counselors, wellness coaches) of professionals toward our mission of providing community-focused, evidence-based, and culturally-competent behavioral health services through the integration of best practice research, training, and technical assistance. The Center for Behavioral Health and Wellness has three units: Clinical Unit, Research Unit, and Training Unit. I provide oversight over all projects and divisions of the Center. I supervised a group of staff, graduate students, undergraduate students, interns, and consultants who provided direct clinical services that outreach specifically to the community. We were connected to several third party payment companies (Medicaid, insurance panels) and provide services to those in need throughout the surrounding community. We conducted research on a variety of topics including the integration of behavioral and physical health, integration of co-occurring disorders into treatment, and trauma and poly-victimization. We trained professionals across the country on the implementation of evidence-based practices in behavioral health settings. I was responsible for fiscal management, personnel management, grant securement, and grant tracking. I secured over \$3 million dollars in grants and contracts over 3 years.

I provided oversight for projects related to violence, trauma, and community well-being. I supervised a group of staff, graduate students, undergraduate students, interns, and consultants. I also served as an adjunct faculty member to doctoral level clinical psychology program. Prior to 2007, I served as a consultant to several grant projects, including the North Carolina Statewide Adolescent Substance Abuse Project in partnership with the North Carolina Department of Health and Human Services. I assisted with Project SAFE (Supporting, Advocating, and Furthering the Education of Our Immigrant Youth), which aimed to increase community awareness,

strategic planning, and preventive interventions for school-based violence among immigrant youth. I served as the Data Director, Guilford County System of Care Program. In this role, I recruited, collected, analyzed, and reported data to a large variety of audiences and retained participants for a 6-year longitudinal study with children with severe emotional disturbance (SED) and their families. I worked to develop multidisciplinary teams for comprehensive treatment planning; evaluated the system of care intervention model. I made recommendations for improving the therapeutic model. I participated in additional grant writing projects at the state level. I delivered local, state, and national presentations about the model and wrote several articles to document the model's national relevance.
